**1. Atticus Academy reserves the right to refuse services to any individual without notice or justification.**

**2. Application:**

Once applicants have submitted all required documents they will be listed as “provisionally accepted”. This means that their documents are under review and / or there are document(s) still outstanding. Only after all requirements were fully reviewed and confirmed, will the status be changed to “confirmed”. Provisional acceptance may be forfeited under the following circumstances:

- Applicant fails to provide required documents by the deadline stipulated in communication with our student support staff
- Non-compliance is found in the documents and this cannot be rectified by the stipulated deadlines.
- The applicant is refused a visa by the immigration authorities of the UAE for any given reason. As a result, the applicant will forfeit his / her provisional acceptance status.
- The applicant failed to make full payment by the stipulated deadline.
- The applicant has provided false or misleading information

**3. Internship / employment in Germany**

While we guarantee to provide each graduate of our Dubai courses with employment or an internship respectively, the following circumstance would make such a guarantee null and void:

- The student does not pass the require exams to obtain the relevant certifications during his / her studies in Dubai
- The student does not pass the required German language test at Goethe Institut with the stipulated passing-percentage
- The student fails to pay the quoted internship / job placement fee by the stipulated deadline
- The student is refused the required visa by the competent German authorities

Our partner in Germany and / or the employer / internship provider reserves the right to terminate said employment / internship under the following or other circumstances which make continuation unacceptable:

The participant

- comes in conflict with German laws more than once after warning
- has running-ins with law enforcement
- conducts him / herself in an unacceptable manner deemed unsustainable at the discretion of the employer
- has his / her visa revoked by a competent German authority

- refuses more than once to comply with instructions by the employer / internship provider

**Our services in Germany** include the following:

- establishing employment / internship for the respective graduates based on their specialization, for the stipulated time-periods
- introduction and on-boarding of the graduate with the respective employer
- visa assistance – submission of documents
- housing assistance – suggestions and recommendations
- airport transfer.

**Our services in Germany** exclude the following:

- Provision of housing,
- any assistance, whether monetary, legal or otherwise, above and beyond the aforementioned.

**Graduates pay for their housing, local transport, their local livelihood, and the German visa. Social security deductions from their salaries / stipends apply in line with German law.**
